

ORDINANCE 145

AN ORDINANCE OF THE TOWN COUNCIL OF THE INCORPORATED TOWN OF DARBY,  
AMENDING TOWN CODE 5-6-1 LOCATION OF STOP SIGNS.

WHEREAS; the Town Council desires to provide safe traffic ways for public vehicles and pedestrian, and

WHEREAS; it is the desire of the Council that a stop signs at the intersection of Waldo and North Marshall Street, and

WHEREAS; stop signs shall be installed on both sides of the intersection of Waldo and North Marshall Street with the stop in favor of traffic on Waldo, and

WHEREAS: additions and/or amendments shall be indicated by *bold italic print*, and

WHEREAS; this ordinance shall be incorporated into minutes of a regularly scheduled meetings of the Town Council for each of the two required readings.

BE IT ORDAINED by the Town Council of the Incorporated Town of Darby, Darby Montana that:

SECTION 1

That section 5-6-1 of the Town of Darby Town Code is hereby amended to read:

5-6-1: LOCATIONS Stop signs shall be erected at the following intersections:

The effective date of this ordinance shall be thirty days (30) after passage of the second and final reading by the Darby Town Council.


